

The bids will be opened in the presence of Bidders' representatives who choose to attend at 2078/10/28 13:00 at the office of Department of Labour and Occupational Safety Minbhawan, New Baneshwor, Kathmandu, Bagmati Province. Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security amounting to a minimum of Nrs.28,000, which shall be valid for 30 days beyond the validity period of the bid (i.e. [Refer Clause ITB 20.1]). If bidder wishes to submit the Cash Security, the cash should be deposited in Deposit Account No. [1201200001002524], at [Nepal Rastra Bank, Baluwatar, Kathmandu] and submit the receipt of the deposited amount of cash along with the Sealed Quotation.
